**ORDINANCE NO: 2024-01**

**AN ORDINANCE TO ESTABLISH CLASS B ROAD DESIGNATION FOR A  
PORTION OF 80<sup>TH</sup> STREET, 90<sup>TH</sup> STREET, 280<sup>TH</sup> AVENUE, 290<sup>TH</sup> AVENUE AND  
100<sup>TH</sup> STREET IN THE TOWN OF BONE LAKE.**

The Town Board of the Town of Bone Lake, Polk County, Wisconsin, has the specific authority under § 349.15(2), Wis. Stats., to adopt this ordinance.

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, designates the following town highways as class “B” highways in the town:


- A. That portion of 80<sup>th</sup> Street located in the Town of Bone Lake from County Road O to 280<sup>th</sup> Avenue is designated as a class “B” highway subject to the weight limits set forth in § 348.16(2), Wis. Stats., unless increased by town ordinance.
- B. That portion of 90<sup>th</sup> Street located in the Town of Bone Lake from State Highway 48 to 290<sup>th</sup> Avenue is designated as a class “B” highway subject to the weight limits set forth in § 348.16(2), Wis. Stats., unless increased by town ordinance.
- C. That portion of 280<sup>th</sup> Avenue located in the Town of Bone Lake from County Road I to 80<sup>th</sup> Street is designated as a class “B” highway subject to the weight limits set forth in § 348.16(2), Wis. Stats., unless increased by town ordinance.
- D. That portion of 290<sup>th</sup> Avenue located in the Town of Bone Lake from County Road I to 90<sup>th</sup> Street is designated as a class “B” highway subject to the weight limits set forth in § 348.16(2), Wis. Stats., unless increased by town ordinance.
- E. That portion of 100<sup>th</sup> St located in the Town of Bone Lake from County Road I to 280<sup>th</sup> Street is designated as a class “B” highway subject to the weight limits set forth in § 348.16(2), Wis. Stats., unless increased by town ordinance.
- F. The town chairperson, or his or her designee, shall place appropriate traffic signs on the above-described highways on or before the effected date of this ordinance.
- G. No person may operate any vehicle on the above-noted highways in violation of the weight limits in § 348.16(2), Wis. Stats. Any person who is found to have violated this ordinance shall be subject to those penalties found in Wis. Stat. Sec. 348.21 and those penalties are hereby adopted by reference including applicable surcharges, assessments, and costs for each violation. Each trip in violation of this ordinance constitutes a separate offense. In addition, the town board may seek injunctive relief from a court of record to enjoin further violations.


This ordinance is effective August 1, 2024.
